

MINUTES OF THE MEETING FOR THE MONTH OF MAY, 2017 HELD ON 26.05.2017 AT 4.15 P.M. AT THE OFFICE CHAMBER OF THE DISTRICT & SESSIONS JUDGE, CACHAR, SILCHAR.

The D.C Cachar, is represented by the A.D.C., Cachar. The S.P., Cachar is represented by Dy. S.P., Additional S.P., Karimganj is also present, the Superintendent, S.M.C.H, is also present along with the officers including the learned Member, M.A.C.T., Presiding Officer Family Court, and other judicial officers are present to discuss the agenda of revised action plan about special attempt for executing processes relating to old pending cases.

During the discussion, it was discussed that due to the transfers of the I.O. from time to time, they could not be procured for adducing their evidence. Hence, it was suggested that the Police Administration may furnish the names and phone numbers of all the I.O.s to the District Courts which would enable the courts to contact the I.O.s for adducing their evidence. In case of their new assignees, their names may also be furnished from time to time.



In this regard, the District & Sessions Judge, Cachar and the SDJM(M), Lakhipur has furnished a list of cases which are pending due to the failure of the I.O.s to turn up and all of them are old pending ones. The same is handed over to the Dy.S.P., Cachar who has assured that prompt action will be taken in those cases.



Further, the Presiding Officer, Family Court, Cachar, Silchar has also pointed out that the warrants issued from her courts are not being executed and the reports sent are also not proper ones, especially of the Distress Warrants.



There was also a discussion held on the follow up of the resolutions of the Zonal Conference held on 19.11.16 at Silchar of the 3 Districts of Cachar, Karimganj and Hailakandi wherein the S.P. of the 3 districts were asked to update informations in their websites as regards the names of the I.O.s and their telephone numbers and other details. Accordingly, the Addl. S.P, Karimganj and the Dy.S.P., Cachar are asked to ensure that the resolutions which were taken are followed and necessary steps are taken up.

The efforts on part of the District Administration as per the earlier resolution which has resulted in sending of the Saham reports to the Civil Courts is highly appreciated and the same may be maintained and all pending reports may be sent earlier.

MINUTES OF THE MEETING FOR THE MONTH OF MAY, 2017 HELD ON 26.05.2017 AT 4.30 P.M. AT THE OFFICE CHAMBER OF THE DISTRICT & SESSIONS JUDGE, CACHAR, SILCHAR.

The D.C Cachar, is represented by the A.D.C., Cachar. The S.P., Cachar is represented by Dy. S.P., Additional S.P., Karimganj is also present, the Superintendent, S.M.C.H, is also present along with the officers including the learned Member, M.A.C.T., the Presiding Officer, Family Court, and other judicial officers are present to discuss the agenda of revised action plan about special attempt for executing processes relating to old pending cases.


During the meeting, the Additional S.P., Karimganj has submitted that due to failure of the I.O.s to collect the medical documents of the injured persons/victims, the cases are still pending at the stage of investigation and accordingly has sent a list of such cases to the S.M.C.H authorities and the Superintendent, S.M.C.H. has assured that he will take necessary steps and has received the list and ensure that the same will be sent expeditiously. It is also informed that process of computerization of records is going on and the same will be completed soon.

It is also resolved that the every medical reports wherein X-ray and Scan reports are involved especially in cases involving offences of rape and sexual offences, the injury reports is required to be enclosed with at least a certified copy of the relevant radiological reports etc.


The Dy.S.P., Cachar, Silchar was informed as regards the trial of one case being N.D.P.S. Case No-15 of 2013 which could not be proceeded as the I.O. has failed to furnish the sample of the seized contraband substance and has informed the court that the same was sent to the FSL for examination. It has been pointed out by the Sessions Judge that already the FSL report has been collected and accordingly, the sample also ought to have been sent to the court with the report. The Dy.S.P. has been asked to ensure that the I.O.s and the authorities ensure that the remnants of the samples are produced before the court and their present status are kept in record to trace them out whenever required.

It has been expressed by all concerned that the Health Authorities may make an endeavor to computerize the records as regards the medico legal reports and keep track of the same for their future use. It has also been suggested that the Police Administration may also endeavor to computerize the records to keep track of the seized articles. Further, they may make some efforts to include the educational qualification of the victims/witnesses and accused persons in the case diaries.
