


**MINUTES OF THE MEETING FOR THE MONTH OF OCTOBER, 2017 HELD ON 31.10.2017


It is also pointed out that in many cases, the I.O.s have failed to submit the case in F.F. and the accused are detained in Jail Hajot for some time but due to the seriousness of the allegations, they cannot be enlarged on P.R. bond. It is discussed that steps may be taken up to ensure that cases where the accused persons are detained in jail are submitted in FF expeditiously.


