CACHAR, SILCHAR.**



It has been also discussed that steps may be taken to ensure that the permanent addresses of the I.O. are provided at the time of filing of the charge sheet. Further, there has been a discussion that the resolution adopted on 25.08.18 as regards furnishing of names and phone numbers etc. of the M.O. & I.O. in the charge sheet have not yet been followed and it has been urged that the same may be taken up with the O/C of the concerned police stations for doing the needful.

The D.C Cachar, is absent and none is there to represent him. The S.P., Cachar is represented by D.S.P., Aoicharjya JibonBaruha. The representative of the Joint Director, Health Services, Dr. Sumana Naiting, S.D.M.O. is also present along with the officers including the learned Member, M.A.C.T. and other judicial officers are present to discuss the agenda regarding investigation of cases.


As the Executive and the Police Department were busy in organizing the Namami Barak festival, the meeting for the month of November could not be held.

It has also been discussed that in some heinous cases, the accused persons are detained in jail for quite some time but as charge sheet have not been filed till date, the trial has not started. It is also pointed out that in many cases, the I.O.s have failed to submit the case in F.F. and the accused are detained in Jail Hajot for some time but due to the seriousness of the allegations, they cannot be enlarged on P.R. bond. One such case being Udharbond P.S. Case No-99/16 u/s 304 B, IPC wherein the accused has been detained for almost 2 years and till date charge sheet or has not been filed. The D.S.P., Sri Baruah has assured that he will look up into the matter.


In some other cases, it is seen that the I.O. has submitted that the final charge sheet has not been filed as some of the accused persons are yet to be arrested. It has been discussed that as per the resolution adopted in the Zonal Conference held in November, 2016, it was urged by the Hon'bleThe Chief Justice, Gauhati High Court that the I.O. may file preliminary charge sheet in such cases and may make a prayer for allowing them to file additional charge sheet later.

It is also asked that in all cases, the I.O. would endeavour that **wherein** charge sheet are filed u/s 325, IPC, that the X-Ray report along with the X-Ray plate are also furnished.
