The board held its meeting on 27/12/2020 at 11 A.M. in the Katigorah P.S. and decided that the seized coal will be sold in public auction on 18<sup>th</sup> January, 2021 At 11 A.M. at Katigorah P.S.

The intending bidders will submit sealed quotation affixing Court Fee Stamp of Rs.8.25/- only with demand draft of Rs.10,000/- only for dumped coal in the form of the Bank Draft in favour of the Superintendent of Police, Cachar, Silchar. Without earnest money no tender will be accepted. The earnest money will be returned after disposal of dumped coal.

The successful bidders shall have to remove the dumped coal on the same day at his own risk and cost, after depositing the full bid money, otherwise the undersigned will not be responsible for any damage or loss of the dump coal. The Auction Board has fixed minimum rate to each of the dumped coal. The undersigned reserves the right to reject the highest bidder or any one and may go for open tender if it is felt that reasonable price of the dumped coal has not been quoted by bidders.

The dumped coal may be inspected in the Katigorah P.S. areas in any working day from the date of the auction notice.
