5. Maintenance applications.
6. Application for Protection order under the Provsion of women from Domestic Violence Act, 2005.
7. Recording of statement u/s 164 of Cr.P.C. of the victims and confession of statements of the accused persons.
8. Recording of evidence of M.O/I.O./ through video conferencing.
9. Cases at the stage of arguments.

**Civil Cases**

1. Submission of examination-in-chief on affidavits.
2. Injunction matter.
3. Execution matter when urgent stay is required.
4. Cross examinatio of witness before advocate Commisioner by maintaning Covid-19 protocols.

Further, entry of outsiders shall be strictly prohabled in the Court premises unless specifically directed by the concerned authority or unless personal apperance of the party is required in a judicial proceeding. No person, expect the Id. Advocates/parties appearing in person, who are to address arguments, shall be permitted in th Court rooms.
