Applications are invited from citizen of India as defined under Article 5 and 6 of Constitution of India, for filling up vacant post of Sheristader in the establishment of Motor Accident Claims Tribunal (MACT), Silchar, Cachar as per provisions of Rule-6 Read With Rule -16 of the District and Sessions Judge's Ministerial Service Rule, 1987, in the usual pay scale as below:-

1. For the post of Sheristader, the candidate must possess a Bachelor Degree in any stream and should have served continuously for a minimum period of :-
 - (i) 1 (one) year as Sheristader of the establishment of Additional District and Sessions Judge, or
 - (ii) 1 (one) year as Head Assistant of the establishment of Additional District and Sessions Judge, or
 - (iii) 3 (three) years as Sheristader of Civil Judge/Munsiff or
 - (iv) 4 (four) years as Supervisory Assistant in the establishment of District and Sessions Judge, or
 - (v) 6 (six) years as Upper Division Assistant (UDA) in any judicial department
2. The application should be submitted through proper channel in Standard Form as published in Assam Gazette Part-IX.
3. The application must accompany a self-addressed envelope affixing postage stamp of Rs.5/-, self-attested copies of all relevant documents/testimonials in support of their educational and other qualifications including work experience.
