Terms & conditions:-

1. The contract period will be initially for 1 (one) year which may be extended (if necessary) or till new vehicles are provided by the Hon'ble Gauhati High Court.
2. The maintenance of the vehicle shall be done by the outsourcing vendor (except fuel & remuneration of driver).
3. The interested parties (vendor) must have Savings Bank Account in SBI & GST Registration No., Pan Card No. etc are to be provided for online payment of bill.
4. The filled up quotation shall be submitted in a sealed envelope and it is to be marked as "Quotation for Outsourcing of Vehicle" in the top of front side of the envelope.
5. The monthly payment of the vehicle shall be made through online mode in the bank account of the selected vendor after submission of bill.
6. The undersigned reserves the right to cancel the present tender process without assigning any reason in case any untoward situation arises.
7. The undersigned shall have the right to cancel the contract of the selected vendor at any point of time without assigning any reason thereof.
8. The undersigned reserves the right to counter offer price against price quoted by the bidder.
9. The vendor/party quoting the lowest bid price shall be awarded the contract.
10. After selection of the lowest bidder, he shall have to make an agreement with the Chief Administrative Officer of the office of the undersigned regarding the terms and conditions of the contract.
11. After selection of the lowest bidder, the vendor shall deliver the brand new vehicle within 1 (one) month from the date of intimation of his selection.
12. The interested party/vendor shall provide brand new vehicle registered for the commercial purpose only.
13. The vehicle should have comprehensive insurance cover along with registration. The insurance cost, road tax etc. due on such vehicle shall be the liability of the vehicle owner. The vehicle should be insured in any of the Nationalized General Insurance Companies.
